Summary of Beneficiaries' Complaints and Requests

Summary of Beneficiaries' Status of Violation

Performance Report . . . According to SHMFF's Acceptance of Governance Principles and Transparency, the Performance Report is periodically Issued to Present the Fund Indicators 2nd Quarter 2021/2022 of the Social Housing Program.

About SHMFF ... SHMFF was established according to the presidential Decree No. 93 of 2018, to assist the government of EGYPT to improve the performance of housing sector through designing and implementing new programs that will address the housing gap to provide adequate and affordable housing units for Egyptians Households.



- The report is reflecting the most important internal Economic Results and Indicators that took place during the period (Oct - Dec) 2021 which has impacts on the Fund.
- During the 2nd quarter of the fiscal year 2021/2022 total number of beneficiaries reached 16,839; (98%) of them applied for "social housing projects" and 63% of the beneficiaries are between 31-40 years old representing the highest percentage of regarding age groups. out of the total beneficiaries 50.5% are working for the private sector representing the highest percentage of beneficiaries regarding (work classification category), while 69.2% of the total beneficiaries are Married with kids, and 22.4% their monthly income ranges (L.E 1501 L.E 2000). Beneficiaries from Cairo governorate constitute 25.7% and are consider the highest percentage of total number of beneficiaries, Positive discrimination is giving for Women (women with children, divorced women and widows), 25% of total beneficiaries are females.
- The total value of disbursed subsidy amounted for L.E 335,6 million during the 2nd quarter of the fiscal year 2021/2022, with an average subsidy to each beneficiary of L.E 19,932. The total value of financing reached L.E 2,522 billion, with an average financing of L.E 149,825, (21,976) units have been allocated out of which 21,960 for Social housing projects, 95.2% are (90 m²) due to high demand.
- Performance level of the call center and customer service is 94%, and the total number of SMS that have been sent to applicants using (1124) service reached 131,303 SMS. SHMFF's Facebook page followers increased to reach 364,000 followers, in addition the total number of visits to SHMFF Portal reached 10,1 million visits. The Fund launched 14 Illustrative Videos on its official YouTube channel during the 2nd quarter to illustrate new services, with total views of 33,193 views.

- SHMFF call center service received 11,795 requests and 60,98 complaints using (090071117 - 1188 - 5999 - 5777) facilities, and also received 5,310 complaints & suggestions through different channels by (Government complaints portal – complaints received from high board - complaints received on the ministry's customer service).
- Total number of Beneficiaries' Status of Violation that have been recorded 162 allegations,75 out of which are convicted.

The Performance Indicators of the Egypt's Economy during the 1ST quarter of 2021/2022 confirmed the improved Performance of Egyptian Economy which is trending towards recovery from the Pandemic, due to the Economic and Financial Reforms implemented over the last years and many measures have been taken to confront Covid-19.

The Different Sector Growth Rate are as the follows:

- Restaurant and Hotel Sector constitute 181.8%.
- Manufacturing Sector constitute 15.2%.
- Construction Sector reached 10.5%.
- Telecommunications and Information Technology Sector reached 16.3%.

In additional to, Sectors that contributed to GDP which are Manufacturing, Agriculture, Trade and Real Estate.

International Institutions Expectations for Egyptian Economy over the next two years its highly positive, and strong performance exceeding the Southern and Eastern Mediterranean and Arab countries regions.

Egypt's Economic Growth Rate in 2021 was 3.3% and it's expected to grow to 5.4% in 2022, due to the Telecommunications Sector, Investment Sector and FDI Flows, accordingly the following statistics is reflected:

- The Telecommunications Sector is the highest growing sector with 16%.
- FDI Flows and the expansion of vaccination campaigns are expected to contribute to the recovery of Tourism Sector.

Egypt succeeded in Proceeding 6 positions in the National Brand Report, its ranked 45th in 2021 compared to the 51st in 2020, due to the efforts of the country to enhance its position at the Global level and Creating Many Projects and Initiatives, moreover Egypt is among the top 5 Arab countries.

The report measures the performance of 100 countries based on variables that affect the country as a brand which are:

- Internal and External Variables that affect the attraction of Investments such as (Governance, Foreign Relations, etc.).
- Variables affecting the stereotype of the State such as (State Influence,
 Community values, etc.).
- Variables affecting the Economic Performance such as (GDP, Investment, etc.).

Cairo jumping five places in World Cities Index 2021, ranking 59th in the world out of 156 cities, moreover Cairo ranked third in the Arab world countries out of 20 cities and second in Africa out of 14 cities.

The World Cities index is based on five main Axes, including:

- Business Activity.
- Human Capital.
- Exchange of Information.
- Cultural Experiences.
- Political Participation.

Egypt Wins Two International Awards for First Green Sovereign Release in the Middle East and North Africa

Egypt has won two awards for Egypt's first green sovereign release in the Middle East and North Africa in 2020, for the reason that Egypt's efforts to shift towards a green and sustainable Economy, while reducing carbon emissions and increasing dependence on renewable energy sources.

15 projects were contributed to green bonds such as: Monorail Project, Dabaa Desalination Plant in Matrouh, Aswan Water Treatment Plant, Water and Sanitation Projects north and south of Upper Egypt. Green bond proceeds were distributed between: 54% for water and sustainable sanitation projects, 46% for clean transport projects.

Awards received by Egypt are as follows:

- 1. "Green Market Pioneer Award" from Climate Bonds.
- 2. "Sustainable Finance Award" for Best Sustainable Financing Transaction from the Middle East Bond, Loan and Instrument Awards Foundation.

40% Increase in Egyptian Exports During (January-September) 2021

Egyptian exports increased significantly during the first 9 months of 2021, rising by 40% to \$29.7 billion, as the reason for the Egyptian state's strategy to develop exports as the most important source of foreign exchange, in addition to reducing the trade deficit and focusing on high value-added industries. Egyptian Exports were distributed to International Blocs during (January-September) 2021 as follows:

1. G20: \$14.1 billion.

2. EU: \$9.6 billion.

3. Arab countries: \$7.8 billion.

Egyptian Natural Gas Exports Records the Highest Growth Rate in the World

Egypt's gas sector has become one of the most important sectors contributed to Egyptian Exports in recent years, as Egypt seeks to transform to be the regional energy center and maximize the added value of natural gas. Egypt's LNG Exports grew by 900% in the third quarter of 2021, marking the highest growth in the world, because of the growth of domestic production from (Zohr and Atul) fields.

LNG Exports from Damietta plant have reached 1,6 million tonne since returning to work in February 2021. India, Pakistan, China and Spain are the most important recipients of Egyptian Gas shipments from Damietta.

Egypt's accession to the "JP Morgan Index" for Governmental Bonds is a new confirmation and guarantee for the Egyptian Economy. Egypt being one of two countries in the Middle East and Africa in the index contributed by many factors such as the country's ability to Fulfilling its external obligations to investors and international institutions, as well as the stability of the local currency and the ability of the Economy to achieve positive growth rates despite the Corona pandemic.

The transition to renewable energy is a central part of Tackling climate change, so the world is moving to increase renewable energy production. According to the International Energy Agency Report, the world's electricity production capacity from renewable energy is expected to increase by more than 60% between 2020-2026.

More than 3/4 of the projected increase in renewable energy production in the Middle East and North Africa region is concentrated in five countries including Egypt and Saudi Arabia. Egypt's projected renewable energy production capacity in 2021-2026 is expected to increase to 68%, while Globally the electricity production capacity from renewable energy will reach 6% in 2021 compared to 2020.

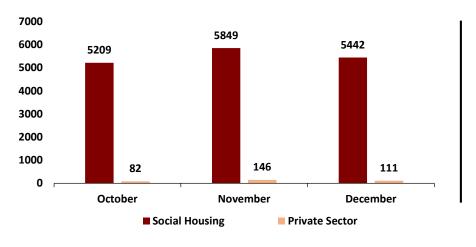


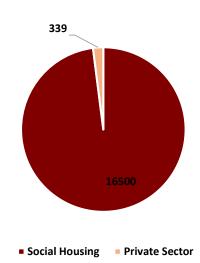

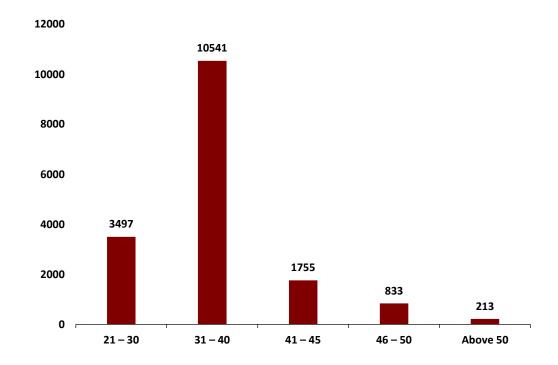




2- Total No. Of Beneficiaries According to Age Group

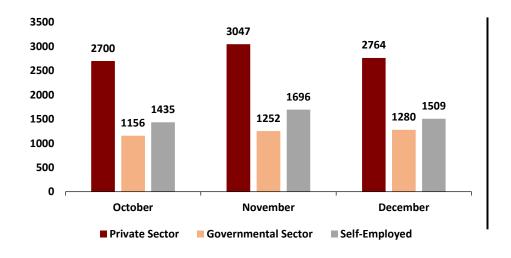

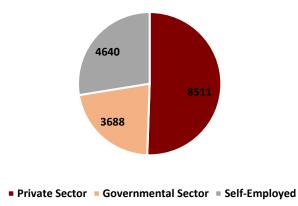

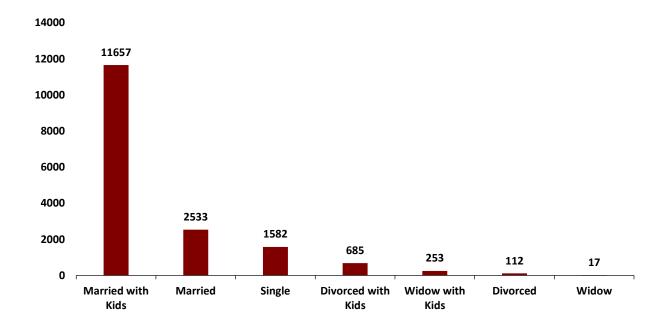

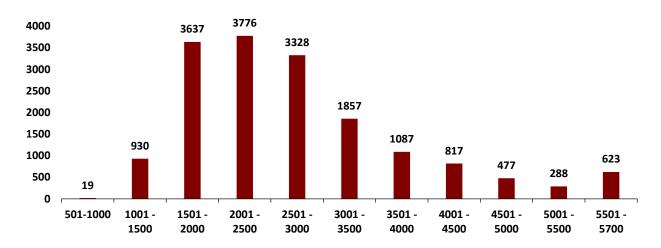

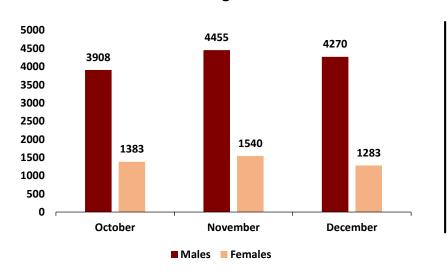

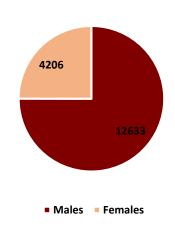

6- Total No. Of Beneficiaries According to Gender

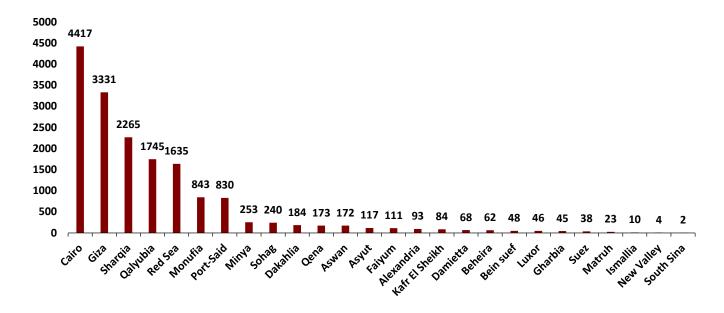
